REGULATIONS / DIRECTIVE FOR BANNING RAGGING & ANTI-RAGGING MEASURES

1. Although there is no ragging case has been found in college campus during past years, even though to root out ragging in all its forms the institution by instituting stringent anti-ragging measures and provisions for strict punishments to defaulters.
2. Terms of reference
 - (a) Supreme court of India recommendation, 02 April 2008 orders
 - (b) UP Govt. order dated 26 March 2009
 - (c) UGC Draft Regulations and Guidelines 14 March 2009
3. What constitutes ragging
 - (a) Any disorderly conduct by words or written or by an act which has the effect of teasing, treating or handling with rudeness any other students.
 - (b) Indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological or physical harm or to raise fear or apprehension thereof in a fresher or junior student.
 - (c) Asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.
 - (d) Teasing, embarrassing, humiliating, assaulting or using criminal force or criminal intimidation, wrongful restraining or committing or causing grievous hurt, kidnaping, extortion or molesting or committing unnatural offences or causing death or abetting suicide, use of criminal force, criminal trespass and intimidation.
4. Prohibition of Ragging
 - (a) Ragging within the college campus and hostels is strictly prohibited.
 - (b) Ragging in any form is prohibited also in the private lodges/ buildings where these college students are staying.
 - (c) No person including students/ staff/ faculty shall participate or abet or propagate ragging in any form.
5. Punishments Ragging is a cognizable offence under the law and the punishments to be meted out have to be exemplary and justifiably harsh to act as a deterrent. It may include :
 - (a) Cancellation of admission, suspension, rustication or expulsion from the College / Hostel.
 - (b) FIR with the police and arrest.
 - (c) Collective punishment may be imposed where involved persons are not identified.
6. Measures for Curbing Ragging

It is clearly mentioned in Admission Form that **"Ragging is totally banned in the College as well as Hostel campus and anyone found guilty of ragging and / or abetting ragging will be appropriately punished."**

IMPORTANT

- (i) A student will not be admitted / registered until undertaking mentioned above is submitted.
- (ii) Students who are allotted Hostel Accommodation are required to submit two copies of details of parents and local guardian address proof along with their photographs on the form.
- (iii) Students will not be registered and assigned hostel seat until the above document is submitted at the time of registration for the Hostel.

Parents / Guardian & Students are requested to read it carefully at the time of admission in all courses

1. At the time of admission candidates are supposed to submit :
 - a) Ten photographs
 - b) Original documents of Class X & XII
 - c) Photo ID Proof (Aadhar Card)
 - d) T.C
 - e) Medical fitness
 - f) Migration Certificate
 - g) Two sets of Xerox of all documents
2. In case of student is willing to fill scholarship form for any category, he/ she has to submit income Certificate and caste certificate with two set of Xerox of each. College will not be responsible for delay to submit the essential documents.
3. No one will be permitted to leave the hostel in mid of the session otherwise he/ she has to pay full fee for the year. In case of any damage loss of articles the amount will be cut off from the security fee.
4. In case of increase in charges of mess and electricity etc hostel fee can be raised in mid of the session.
5. Fees are non-refundable in case of cancellation of admission by the candidate.
6. Fee once paid is not refundable.
7. Fee to be charged is subject to revision and amendment from time to time.
8. Fees must be deposited according to fee schedule for the year.
9. Student discontinuing studies after the 10th July of the admission year (or) in the subsequent year (or) does not join the program by the stipulated date is liable to pay the tuition fee for the remaining year. The college may ask the candidate to submit a bank guarantee.
10. Minimum 80% attendance in theory & 90% clinical attendance is compulsory for the students of each class to appear in final theory & practical exam. In case of Lack, fine and compensation duty will be imposed.
11. Compensation duty should be completed before the theory exam. Otherwise, students are not permitted to write exam.
12. Internal marks will be awarded according to the class attendance and class performance.
13. Students should not be involved in ragging, teasing, treating or handling with rudeness to a fresher or any other students, in disciplined activities which cause annoyance hardship, physical or psychological hard, all kinds of abuses which disturb regular academic activity.
14. If students found guilty of ragging he/ she will be liable for punishment according to rules.
15. Students have to follow the rules & regulations of college as well as hostel strictly.
16. Security amount Rs. 2000/- for college and Rs. 3000/- for hostel maintenance should be deposited in the very first month of the session. Security amount is refundable after the completion of the courses.
17. Security fees Rs. 2000/- for college will be deposited in the month of August & Rs. 3000/- as maintenance charges of hostel have to deposit at the time of joining the Hostel.
